



Total Special Education Systems (TSES) and Charter Schools

What is a TSES?

The TSES is a school district's written plan for providing special education and related services to ensure compliance with special education mandates in federal and state laws. Districts may write their plans individually or as members of a special education cooperative.

How does the TSES apply to charter schools?

Charter schools are public elementary and secondary schools, so they must comply with special education statutes and rules. Most charter schools are independent school districts. All school districts, including charter schools, must submit a TSES plan to the Minnesota Department of Education.

What does a TSES plan consist of?

Minnesota Special Education Rule 3525.1100 lists the areas that must be covered in the plan. The following chart outlines the requirements:
